### **BACKGROUND**

The rate of new HIV infections is decreasing globally, however in Eastern Europe and Central Asia (EECA), the HIV epidemic continues to grow. According to UNAIDS, there are approximately **1.7 million people living with HIV** in the region. The HIV epidemic in EECA has grown by 29 percent since 2010, reflecting insufficient political commitment and domestic investment in national AIDS responses across much of the region.

Additionally, the legal, policy and regulatory frameworks that govern national efforts in prevention, treatment, care and support need significant strengthening. Some key obstacles include the criminalisation of or increased punitive measures against HIV transmission, sex work, and drug use or possession for personal use; the introduction of homophobic

and transphobic laws usually "anti-propaganda" presented as punitive "prevention" legislation; measures against people with HIV as those more likely to commit crimes; forced and coerced HIV testing; prosecution of the people who are not able to or willing to undergo TB treatment; and a shrinking space for civil society organizations to provide

services for those living with HIV, TB and other key populations.

In its flagship "Risks, Rights & Health" report of 2012 and subsequent 2018 Supplement<sup>1</sup>, the Global Commission on HIV and the Law (GCHL) recognized that the law alone cannot stop HIV transmission, nor can the law alone be blamed when HIV responses are inadequate. However, the GCHL found that legal environments can play a powerful role in the well-being of people living with or vulnerable to HIV<sup>2</sup>. Without the contribution of judicial members in combatting HIV and related conditions, it is unlikely that significant change in how HIV and co-infections is comprehended on a societal, legal and medical level will be actualized.

In response to the Global Commission's recommendation, the United Nations Development Programme (UNDP) has been facilitating the work of the African Regional Judges' Forum on HIV and AIDS, which held its sixth meeting in 2019. As the Forum proved to be an important platform for information and experience exchange, raising awareness and sensitizing members of the judiciary on the issues of HIV and key and vulnerable populations, UNDP supported participation of EECA judges in the meetings of the African Judges Forum in 2018 and 2019. Thus far, the meetings were attended by four EECA judges (from Ukraine, Moldova and Tajikistan), creating a clear demand by these judges to replicate the experience in the EECA region.

The first meeting of the First EECA Judges' Forum on HIV and AIDS took place in Chisinau, Moldova, on 3-4 October 2019. It gathered over sixty participants, including members of the judiciary, representatives of national judicial training institutes, officers of UN country offices, and civil society and community activists from 11 countries of EECA, as well as representatives of headquarters and regional offices of UN agencies (Annex 1).

#### **MEETING REPORT**

**The first day** of the Forum started with welcoming remarks of Amitrajit Saha, HHD Team Leader for Africa, Addl. Charge of HHD teams in EECA and Arab States, UNDP IRH, Diana Scobioala, Director of the National Institute of Justice of the Republic of Moldova, Gerd Trogemann, Manager of the UNDP Istanbul Regional Hub, Dima Al-Khatib, UN Resident Coordinator a.i./UNDP Resident Representative for the Republic of Moldova, Ruslan Poverga, General Director of the NGO Positive Initiative, Moldova, and Judge Olena Volkova from Ukraine.



Welcoming notes were followed by group photo, introduction of participants, setting expectations and ground rules.

**The first session,** Setting the Scene, featured three presentations: "Overview of governance and peace building in EECA (focus on human

**The second session** of the day focused on criminalization of HIV transmission and exposure, which focused on international guidance with respect to laws criminalizing HIV transmission, covered by Amitrajit Saha, and then the biomedical and scientific information regarding HIV transmission, presented by Elena Vovc, Technical Officer of the WHO Regional Office for Europe.

**The following four sessions** explored the impact of criminal laws on key populations. **Session 3**, focusing on people who use drugs, featured four panellists. Bulat Mukhamedzhanov, Lawyer of the AGORA International



Human Rights Group, spoke about HIV, TB, Hepatitis C, people who use drugs and the law. Fliza Kurcevic. Membership and Programme Officer of the Eurasian Harm Reduction Association, addressed the importance of harm

reduction programmes as an evidence-based intervention, which significantly reduce the risk of transmission of HIV and other blood-borne infections among people who use drugs, contribute to improving the quality of their life and promote their access to other essential HIV services. Zhannat Kosmukhamedova, Head of UNODC Regional Programme Office for Eastern Europe, spoke about HIV, TB and Hepatitis C in prison settings. A personal story by Aidana Fedosik, NGO "New Life", Orenburg, Russian Federation, who was repeatedly sentenced and incarcerated because of her drug use, gave the participants an opportunity to reflect on the negative impact of extensive and unnecessary incarceration of people who use drugs, and the importance of harm reduction and rehabilitation programmes.

**Session 4** focused on the *impact of criminal laws on LGBTI communities*, including men having sex with men (MSM) and transgender (TG) people. The panel had three members -- Vitaly Djuma, Executive Director of the Eurasian Coalition on Male Health, and Dragana Todorovic, Executive Co-Director of LGBTI Equal Rights Association for Western Balkans and Turkey (ERA), made a Legal overview of rights in the context of MSM and TG people, and Anastasia Eva Domani, member of ECOM and TransCoalition, who shared her story of transition and challenges she faced in family and social life. This session gave participants a unique opportunity to hear about the challenges faced by LGBTI communities and to understand how these challenges hamper access of LGBTI persons to HIV services.

**Session 5**, the first session of the second day, explored the *impact of criminal laws on sex workers*. The panelists included Andrey Poshtaruk, UNFPA Regional Advisor, Marina Avramenko, Chair of Sex Workers' Rights and Advocacy Network (SWAN) Management Committee, and Natalia Isaeva, Board member of the Global Network of Sex Work Projects (NSWP), who made a legal overview of rights in the context of sex work, and explained personal impact of criminalization. Participants learned that criminalization of sex work, stigma, discrimination and violence against sex workers all contribute to their vulnerability to HIV and limit their access to prevention, care and support services. The panelists also explained the difference between de-criminalization and legalization of sex work, stressing that de-criminalization, not legalization, is beneficial both for sex workers and for the society.

**Session 6** had a double focus. The first part of the session unpacked the impact of criminal laws on migrants. It featured presentations by Jamie Calderon, Senior Health Advisor of the IOM Regional Office, and Igor Pchelin, Director of "Shagi" Foundation. Armed conflicts, natural disasters and severe poverty force millions of people to seek refuge in richer countries, and EECA is not an exception. It is a region with considerable labour migration, with Russia being the largest recipient country. Prevalent stigma, lack of legal protections and provisions on deportation of HIV-positive foreigners discourage labour migrants from seeking diagnosis, and the requirement to go through an HIV test in order to obtain work permit push many to illegal labour market.

**During the second part of the session**, devoted to *TB and the law*, Dr. Viorel Soltan from the Stop TB Partnership and Timur Abdullaev, Board member



of TBpeople, the alobal network of people affected by TB, presented basic facts about TB and gave an overview of the psychosocial and economic impacts of TB all levels alobal, national, community and individual. **Participants** learned, also in comparison to HIV, that TB is more difficult

to prevent, diagnose, and treat, which explains why TB, being a preventable and curable disease, continues to be number one infectious killer in the world, and the main cause of death for people with HIV.

**During Session 7** participants explored the *importance of strategic litigation cases, monitoring of rights violations and the provision of legal aid.* The panelists included Bulat Mukhamedzhanov, Lawyer of the AGORA International Human Rights Group, Olesea Doronceanu, Lawyer of IDOM, Moldova, and Evghenii Golosceapov, Member of the Council for Preventing and Eliminating Discrimination and Ensuring Equality. They described how strategic litigation can lead to changing laws and practices, giving real life examples of litigation in national and international courts (such as European Court of Human Rights).

**At the end of the session**, Dr. Amirajit Saha, HHD Team Leader for Africa, Addl. Charge of HHD teams in EECA and Arab States, UNDP IRH, shared the experience of establishing and further strengthening the Africa Judges' Forums, which was funded by GF Africa grant through UNDP Regional Service Centre for Africa.



The last session of the event, moderated by Judge Volkova from Ukraine, aimed to discuss next steps. The participants shared their impressions of participation in the first EECA Regional Judges Forum, such as the level of attention being paid by

the judiciary to the issues of HIV and the law, the positive impact Forum sessions had on judges, as well as the importance of having representatives of the communities sharing their personal stories in sensitizing Forum participants.

The First EECA Regional Judges Forum was closed by Dr. Rosemary Kumwenda, HIV, Health and Development, Team Leader for EECA, UNDP IRH and former Justice Olga Shapovalova.

It was agreed that the EECA Forum should also go beyond one-off event and become a sustainable platform for information and experience exchange among judges of EECA countries on matters related to HIV, TB, Hepatitis C and key and vulnerable populations. It was also agreed to form a steering committee consisting of Judge Olena Volkova and Olga Shapovalova from Ukraine, Judge Sharof Alanazarzoda and Manzura Raupova, Deputy Director of the Training Center under the Supreme Court, from the Republic of Tajikistan and Judge Igor Chirosca from Moldova, who would coordinate the process of organizing second Judges' Forum, to take place in May 2020 in Dushanbe, Tajikistan. The participants also agreed to create a mailing list for the participants of the Forum to sustain communication.

In order to assess the logistics and substance of the event, the participants were offered to complete a survey (Annex 3). A total of 26 participants completed the survey. Overall, evaluations were very positive; on a scale from 0 to 5, an overwhelming majority of participants gave rating 3 and above, with near half of participants giving maximum score.
